Training courses from Dyslexia Action

Continuing your professional development (CPD)

For 40 years, <u>Dyslexia Action</u> has been supporting teaching assistants, SENCOs, instructors, tutors, lecturers and learning support staff by implementing short courses promoting <u>dyslexia and co-occurring</u> <u>difficulties</u>, <u>memory weaknesses</u>, <u>structured</u>, <u>cumulative multisensory tuition</u>, <u>study skills</u> and <u>assistive</u> <u>technologies</u> to name a few.

Many of our level 4 and 5 units focus on how to nurture the development of school learners with dyslexia with regard to key skills, such as reading, writing, spelling and numeracy. Other units focus on supporting adults with dyslexia and working with learners in an international setting.

These short courses and programmes are quality-assured by <u>The CPD Standards Office</u>. There is also a range of level 7 units for qualified specialist SpLD professionals to refresh and update their specialist literacy programme knowledge through <u>online masterclasses</u>.

How will I learn?

- The courses are delivered online which offers you the flexibility to organise your time to fit around your professional and personal commitments. It also saves you the time and expense of travel and classroom attendance
- Total study time per unit is 3-5 hrs a week, 20-30 hours total study over a 7-week period (4 weeks for specialist level 7 units)

What is available when?

Level 4 and 5 CPD units run six times a year with start dates in September, November, January, March, May and July. Level 7 CPD units generally run three or more times a year or more with various start dates in September, November, January, March, May and July.

Units starting on 8 May:

- Book by 24 April if you wish to pay later or an invoice is required
- Book by 1 May if paying by credit/debit card

Units starting on 10 July:

- Book by 26 June if you wish to pay later or an invoice is required
- <u>Book by 3 July</u> if paying by credit/debit card

Assessment Practising Certificate: New guidelines from the DfE and SASC

Extending the lifespan of assessment reports for dyslexia/SpLD

The Department for Education has changed its evidence requirements for applications for the Disabled Student's Allowance (DSA; for higher education students). Dyslexia/SpLD Reports undertaken at any age will now be accepted for the purposes of a DSA. Please note that Form 8 Access Arrangement Reports are not acceptable as these are not full assessment reports.

Assessment Reports Undertaken Prior to March 2019

Assessment reports that have been undertaken by a fully qualified specialist teacher assessor or an HCPC registered psychologist prior to March 2019 will now be accepted by Student Finance England (SFE) for DSA purposes.

Assessment Reports Undertaken After March 2019

However, from March 2019, dyslexia/SpLD reports at any age should have been produced by a specialist teacher assessor with an Assessment Practising Certificate (APC) issued by an SpLD Assessment Standards Committee (SASC) awarding body such as the Dyslexia Guild or a practitioner psychologist registered with the HCPC for them to be valid for DSA purposes

Grand-parenting amnesty route from March 2019 - March 2020 only

For a limited period qualified and practising specialist teacher assessors with a full level 7 qualification in assessment (e.g. the Professional Certificate in Assessment Practice (Middx) or the Postgraduate Diploma in Dyslexia and Literacy (York) who have not previously applied for, or held, an Assessment Practising Certificate will be able to obtain an APC by completing an application form and uploading a copy of their qualification certificate. The fee is £180 and includes the SASC listing fee of £30. Apply using the Route 1 application.

Maths Anxiety in Schools

The Nuffield Foundation have published a report that investigates the experiences of UK primary and secondary school students and mathematics anxiety. The report grew out of the suggested evidence that functional literacy skills among working-age adults are steadily increasing but the proportion of adults with functional maths skills equivalent to GCSE grade C dropped to only 22% in 2011 (National Numeracy, 2014). Going beyong Phonics to Help Struggling Readers

Liz Sedley, the creator of <u>Dyslexia Gold</u>, takes a look at why some children struggle to learn to read, despite high quality phonics teaching. Read the full article <u>here</u>.

Teenagers who sprayed racist graffiti over a historic school house in Virginia, we given an unusual sentence – reading. From the moment Prosecutor and Deputy Commonwealth Attorney Alejandra Rueda heard about the racist and anti-Semitic graffiti scrawled across the school house in Ashburn, Loudoun County, Virginia, she suspected the culprits were children. The teenagers were unaware of the significance of the building they had defaced. It was the Ashburn Coloured School, an historic building that had been used by black children during segregation in Northern Virginia. Alejandra Rueda drew up a list of 35 books and ordered the offenders to choose one title a month for a year and to write an assignment on each of the 12 books they chose. The titles included Alice Walker's *The Color Purple, My name Is Asher Lev* by Chaim Potok, *I Know Why the Caged Bird Sings* by Maya Angelou, *Cry The Beloved Country* by Alan Paton and Khaled Hosseini's *The Kite Runner*. They had to write 12 assignments and a 3,500-word essay on racial hatred and symbols in the context of what they'd done.
